Whereas the founder had always an earnest desire to make a national i.e. All India Public Charitable Trust for the charity of the needy and persecuted and deprived section of the society and more particularly to help and uplift the deprived, needy and underprivileged people in India and for the purpose of social as well as socioeconomic welfare of human-being and also to protect the endangered honest species of humanity by various means and measures including the socio economic development and moral up gradation to provide them dignity of life so that they could live social, civilized, dignified moral life in the society. - 5- The beneficiary of the said Trust shall be the persecuted class, socially, educational and economically deprived class including Tribes weaker sections of the society including those who are

Take or receive any gift whether money or properties, movable, immovable, donations in the form of debentures, stocks, shares of securities in any company or society whether incorporated or not or whether by gift by a person living or by legacy bequests, will or donations and whtter subject to any special trust or for works connected there with and to take steps for the securing of such contributions for funds as from time to time be deemed expedient.

- v. Lend money free of interest invest, lay aside, deposit in bank or otherwise deal with money of funds of the trust not immediately required for the objects of the trust and to subscribe or purchase, acquire hold, sell, endorse and negotiable in debentures, stocks, shares and securities of every description in the money market, in conformity with the provisions contained in section 20 of the India Trust Act, 1882.
- vi. Borrow or raise funds with or without security in any manner the trust may think fit and repay the same.
- vii. Negotiate with and enter into arrangements with any Government, Authority, Corporation, Board, University or other public bodies as may seem conducive to the promotion or accomplishment thereof and to obtain, collect receive such grants, loans, allowances, rights, concessions and privileges as may seem to comply with the objects and utilize the same.
- viii. In general to do or cause to do done apart from all the acts, stated above, all such other acts or things as shall be conducive to the interest of the trust provided such things or acts are not contrary to inconsistent with the spirit and principles of law under which has the trust been established. However it is clarified that the managing trustee i.e. the settler shall have all power and privilege of Board of Trustees and he shall be entitled to execute all powers and privileges without taking approval from the Board of Trustee, however, subsequent managing Trustee, shall also enjoy this power and privilege.
